SPECIAL BOARD MEETING

6-17-92

5:30 p.m.

PRESENT: Mayor James G. Elliott, Trustee Daniel E. Wooden, Trustee Kathleen C. Drews, Chief David M. Dalton, Sgt. Ron Hall, and Citizens Harold Baker, President Wayne Cty Fair Assoc., and Mike O'Connor.

CALL TO ORDER: Mayor Elliott called the meeting to order at 5:40 p.m.

SALARY INCREASE: A motion was made by Trustee Wooden to give Jim Campbell, Director of the Community Center, the salary increase as recommended by the Community Center Board of Directors, seconded by Trustee Drews, vote, 3 ayes, **CARRIED.**

POLICE DEPARTMENT: Chief Dalton discussed the police coverage in the other Village in Wayne Cty such as: Lyons 9 full time and 2 part time, Clyde 2 full time and 7 part time, Sodus 1 full time and 4 part time, Wolcott 2 part time, Newark 19 full time and no part time, Macedon 3 full time and no part time.

Chief Dalton stated that the Newark Police Chief of 30 years says it has been his experience that part time are not dependable and has found hiring them not to be a good idea. Chief Dalton noted his concerns are that part timers are: not dependable, not available, their priority is not to the part time job, and they are not vested in the values of the Village of Palmyra. Sheriff said that no one experienced is looking for part time work.

Chief Dalton noted that in crimes per month the VOP is behind Lyons by only 5 crimes per month. Trustee Drews asked about a split shift and Chief Dalton told her that the union employees requested 8 hrs on and 8 hrs off and split shifts were not very practical for the employees. Police Clerk, Sue Clemons, explained her job and the duties that she performs. Ms. Clemons noted the additional work she is doing with regards to tickets, filing, etc. and the amount of time involved in different procedures such as bad checks.

Trustee Wooden left the meeting approx. 6:15 p.m. therefore no business was conducted due to lack of a quorum.

The discussion ended at 6:47 p.m. Next meeting is June 18, 1992, at 5:30 p.m. for discussion of police coverage.
