LIFT TRUCK: Motion made by Mayor Elliott to expend up to \$7,000 from the Capital Reserve for Machine and Equipment (HR7) for the purpose of purchasing a lift truck for use in maintenance and up keep in the Village of Palmyra, Cemetery and Parks Department subject to permissive referendum seconded by Trustee/Deputy Mayor Pope, vote, 3 ayes,

SURPLUS ARTIFACTS: A motion was made by Mayor Elliott to declare four (4) Civil Defense arm bands from the WWII period and a set of old wooden clock hands from the old wooden VOP clock which used to be located in the steeple of the Presbyterian Church surplus and temporarily loan these items to the Kings Daughters Free Library for display after which time they will be donated to Historic Palmyra. Motion was seconded by Trustee/Deputy Mayor Pope, vote, 4 ayes, CARRIED.

SURPLUS RECORDS: A motion was made by Mayor Elliott to declare surplus the obsolete records 1950 and before per the official Records Retention and Disposition Schedule MU-1 requirements, and Civil Defense records, Fire wagon picture, and Grammer book. Motion was seconded by Trustee/Deputy Mayor Pope, vote, 4 ayes, CARRIED.
