re Chief  
Cont'd:

anticipated the Hearing Officer's decision being for the Village Board in the form it was - immediate termination of employment. The Board accepted the Hearing Officer's decision as being in the best interests of the Village. There has never been any malice toward Chief Henry, but rather only performance as indicated by the charges which were brought. Too much time and energy has been consumed by this process. This Board recognizes that it can appeal the decision of the Appellate Division regarding Chief Henry. It is our decision to not take an appeal. The court found him to be insubordinate and it will not be tolerated again. We intend that he come back as Chief. We are accepting the Appellate Division's decision and not pursuing the matter further."

Moment of  
Silence:

Mayor Wilson called the meeting to order at 7:09 p.m., following which she requested that a moment of silence be observed.

Committee Reports -

Trustee Green stated that Highway Dept. matters are under control. Regarding the proposed pole barn, Mr. Green said that a letter had been received from Atty. Paul Rubery regarding use of remaining Urban Renewal funds and how it could be spent. Mr. Rubery said he would be glad to call HUD. Discussion held and Trustee DePoint questioned time constraints on the approx. amt. of \$30,000. which has not been expended. Trustee Green said that he would take the matter in hand.

JANUARY 4, 1982

Committee  
Rpts. Cont'd:

Trustee Goulden said that he had nothing to report at this time.

Trustee McGrath brought up the matter of the Town of Manchester/Village of Palmyra Fire Contract for a two-yr. period - an increase to \$1250. for 1982 and \$1500. for 1983, which represents \$250. increase for each year. Following discussion, Trustee DePoint motioned that the Mayor be authorized to execute said Contract; Trustee Green seconded. Upon roll call voting, all voted "aye," motion carried.

Regarding Village Hall renovation, Trustee McGrath stated that front windows had been delivered the previous week and will soon be put in place. She added that renovation is moving along according to schedule. Mrs. McGrath related that she had previously contacted Mrs. Gladys Batterby of the Palette Art Club regarding the painting of historic scenes in the hallway of the Village Hall - and that Mrs. Batterby said that the Art Club is not very functional for such an undertaking. Mrs. McGrath emphasized that she would like historic scenes as opposed to murals, and that she would be contacting the High School Art Department.

12/17/81  
Minutes:

Mayor Wilson asked if there were any corrections or additions to the Minutes of the Regular Bd. Mtg. on 12/7/81. When there were none, Trustee DePoint moved acceptance; Trustee Green seconded. All voted "aye," motion carried.

Regarding the Special Bd. Mtg. on 12/17/81, Mayor Wilson asked for corrections or additions--when there were none, Trustee DePoint moved their acceptance; Trustee McGrath seconded. All voted "aye," motion carried.

Police  
Dept.:

Trustee DePoint stated that he had met the previous week with Chief Henry regarding his returning to work, and his previous meetings with Acting Chief Dalton. Mr. DePoint said that he could not foresee any problems with Chief Henry and Deputy Chief Dalton working together - Dept. looks good at this point. He said that he would be meeting monthly with entire P.D. to discuss any problems which they may have.

Water - Tn.  
of Palmyra:

With the two-year Water Contract to expire on 2/28/82 between the Town of Palmyra/Village of Palmyra, Trustee DePoint said that he is presently working on a proposed new Contract.

Regarding north and south master meters installed by the Town, Trustee DePoint said that he had written his third letter to them requesting that they become operational. He further stated that the purpose of the meters was for the Village to be able to be paid for excess water consumption beyond that used for residential purposes. His letter request to the Town was for a one-year Contract; and an increase in residential rates to \$1.21 for each 100 c.f. delivered per quarter and, in addition, an increase for master meter consumption to \$.87 per 100 c.f. In the event that for the existence of the Contract, the master meters may continue to be inoperative, the Village would bill the Town 25% of the total individual residential quarterly readings at the rate in the proposed Contract. Mr. DePoint felt this would ensure faster compliance for the master meters to become operative. Mayor Wilson added that many oral and written requests had been made of the Town in this regard.

Water Line:

Trustee DePoint said that in a recent discussion with Water Supt., H. Kruger, they are proposing an inspection for water leaks since this had not been accomplished since 1975, and the line is approx. 48 yrs. old. He mentioned looking into some quotes to have a survey done to check the integrity of the water line.

Water Needs'  
Study:

Mr. DePoint spoke of having written to the Town Board requesting that they designate a representative to meet with Village to consider water needs in foreseeable future - series of meetings were held a year ago. Should consider alternatives to what needs to be accomplished with existing water line -

- Water Study Cont'd: survey to be first step and perhaps the second step would be the placement of another water tank. Mayor Wilson spoke of the Town's having formed a "Water Committee."
- Police Dept.: Trustee DePoint spoke of the "No Parking" sign on West Jackson Street and that, according to Chief Henry & Deputy Chief Dalton, same will be enforced.
- Evaluations: Discussion was held on Village employee evaluations, and Mr. DePoint said that the Mayor would be requesting department heads to begin their personnel evaluations. Forms relating to evaluations were discussed and the Board generally agreed to use the same forms as last year so as to lessen confusion. Also, Mayor Wilson felt that by using the same form for two years, one could make a comparison.
- Village Budget: Mr. DePoint mentioned that Board has to begin budgetary considerations, and that he would sit down with Treasurer soon regarding same. A time-table had been received from Donegan Assoc., it was pointed out. Mr. DePoint said that department heads should be alerted to present their respective, proposed budgets. The Treasurer said that this had been accomplished.
- Pigeon Control: Trustee McGrath said that over 1200 pigeons had been trapped and a lengthy discussion was held regarding pigeon problems in other Village areas. It was stated that the Presbyterian Church has a "pigeon problem," also, and that they had requested that a trap be placed there. Mrs. McGrath spoke of Mrs. Mylocrairie having had a trap placed at her antique store by the same firm. Discussion included the health hazards of the pigeons - that the Health Officer could, perhaps, be effective - and a letter written to Agway. The Board agreed to retaining Mr. Reilly for an additional month in the amount of \$300. with a request from Mrs. McGrath to have the "pigeon problem" evaluated in the summer or fall. She said that she would place an item in the budget regarding same.
- Skating Rink: Mrs. McGrath stated that the skating rink liner had arrived and would be in place soon. The question was asked if the liner is re-usable and she said that the liner's cost was \$900. and would be re-usable.
- Pigeons: It was stated that a vote by the Board was needed regarding the pigeons, following another discussion. Mrs. McGrath motioned that \$300. be expended for another month's "pigeon control"; Trustee DePoint seconded. All voted "aye," motion carried.
- Dogs - License: Trustee Goulden said that a request had been received from M/M Rutledge of Howell St. to obtain a license to harbor five dogs. This request was approved by the Board one yr. ago and must be renewed for a \$10. fee. Mr. Goulden said that he had investigated this matter and found no complaints, therefore, he recommended - and moved - that a renewal be permitted. Trustee DePoint seconded, all voted "aye," motion carried. Discussion was held on whether or not the Rutledge's would have to make a request each year, or just \$10. fee paid. Mayor Wilson said that the Village Attorney would have to research same since this situation is unprecedented.
- Workshop - Civ.Ser.: Mayor Wilson read excerpts from a communication received from the Conference of Mayors which told of a Civil Service/ Employment Discrimination Workshop to be held on 1/21/82 at Angola, N.Y. She polled Bd. members regarding attending same, however, none of the Bd. members felt they could attend.
- Grievance Day: Mayor Wilson spoke of Grievance Day on Tuesday, 2/16/82, and the necessity of Board members being present. She said that designation of sessions would occur at 1/18/82 Bd. Mtg.
- Liaison - P.E.D.C.: Mayor Wilson related that the Palmyra Economic Development Corporation had requested a Village Bd. member to act as a liaison person between P.E.D.C. and the Village. When no one volunteered, Mayor Wilson accepted the responsibility in this area.

JANUARY 4, 1982

Village Elec. Workshop:

Mayor Wilson spoke of a workshop on Village Elections to be held at the Board of Elections in Lyons, N.Y. from 9:15 a.m. - Noon on 1/12/82. It was suggested that the Village Clerk attend same - and no vote need be acted upon by the Board.

Contracts:

Mayor Wilson stated that the Town of Palmyra/Village of Palmyra Community Center Contract, in the amt. of \$12,500., had been fully executed; likewise, the Town of Palmyra/Water Supt. Contract for Services in the amt. of \$1800. Regarding the Town of Palmyra/Village of Palmyra Fire Contract in amts. of \$22,000. for 1982 -- & \$23,000. for 1983, Mayor Wilson spoke of urgency of Fire Dept. executing same as quickly as possible.

Zoning Hearings:

Mayor Wilson announced that the following Zoning Hearings shall be held on 1/19/82 - Provo & Schram re Day Care Center at 131 Canandaigua St.; & Columbia Banking/Pal. Motors re a request for a variance to permit continuation of pre-existing, non-conforming use of land, located in an R-1 Zone, for automobile sales operation.

Donegan Assoc.:

Having retained Donegan Associates for the past three years for the Village's investments and budgeting process, discussion was held on entering a new Contract. Mayor Wilson stated that Donegan provides an excellent service to the Village - which is invaluable. Trustee Green moved the passage of Resolution #82-01 authorizing the Mayor to execute a Contract between Donegan Assoc.; Village of Palmyra regarding the Village's budgeting process in the amount of \$3,300. + out-of-pocket expenses; Trustee Goulden seconded. All voted "aye," Resolution #82-01 unanimously adopted and attached hereto.

Laurentian Drive:

The water leak on Laurentian Drive was discussed at length by the Board. Trustee DePoint spoke of having talked to Water Supt. & Village Atty. regarding this problem and it appeared to be an agreement between two parties as to repairs on a water line which was put in. The problem is that the water line is no longer on property belonging to either of the people and this does not involve the Village. There is a water loss and could create a safety problem - Trustee DePoint suggested that letters be sent to both parties stating that this is their responsibility and not a Village obligation. After a certain period of time, if parties have not resolved the situation, then shut water off. Trustee McGrath felt that this was not the solution - they are Village taxpayers. Trustee Goulden asked if the Village could fix it and charge it to them. It was stated that the parties involved could not afford this expense. The legalities were discussed and putting in a new line and charging them, and the possibility of tying into Marber's 6" water line.

Mayor Wilson emphasized that the Village could not go on the street to repair since said street had never been dedicated to Village. A previously mentioned agreement was brought up, however, Mr. DePoint said neither he nor Village Atty. had seen any such agreement. When asked how far apart the two lines are, Mr. DePoint said that they are on each side of Laurentian; the leak is beyond junction point - beyond area of Village control. Mayor Wilson suggested that more research be conducted by Atty. Poyzer. Trustee Green felt that there is a Village obligation in that it costs taxpayers money since the water is treated - throwing money away. It was re-emphasized that letters should be written to the two parties involved and discussion was discontinued.

Hist. Preser.:

Mayor Wilson read a letter from the State in which it clearly stated that no funds would be available for historic preservation. It was suggested that requests should be made for respective applications to be returned or same would be destroyed in one month hence.

Former "Skorc" Property:

Discussion held on the former "Skorc" property and having same appraised. Trustee McGrath said that figures of \$80. & \$200. had been received locally. Trustee DePoint moved that the \$80. estimate from LaLonde be accepted; Trustee McGrath seconded. All voted "aye," motion carried.

Sewer  
Reduct.:

Trustee DePoint brought to the Board's attention that Miss Helen Smith of 202 Canandaigua Street had made a letter request to have the number of sewer units reduced at her residence from four units to three units, permanently - \$84. to \$63. It was pointed out that this was irrevocable, following which Trustee DePoint moved that Resolution #82-02 be adopted regarding reducing said sewer units from four to three; Trustee McGrath seconded. All voted "aye," the unanimous passage of Resolution #82-02 was announced and the Clerk instructed to inform Miss Smith of same. Resolution #82-02 attached hereto.

Assess-  
ments:

Mayor Wilson said that Atty. Paul Rubery would be glad to attend a future Bd. Mtg. regarding assessments for Conifer, Swiss Chalet, Salzburg, etc. A letter from Mr. Rubery indicated that assessments had been settled, however, it was not specified the amounts of money it will mean regarding refunding in the Village. Atty. Poyzer said that she had not received any notification.

Water  
Assess-  
ments:

Mr. DePoint asked Atty. Poyzer about water billing on pipe lines and was told that the Canandaigua problem had been resolved, however, a determination has to be made regarding Gorham & Hopewell as to how they reached assessment figures.

Mummers'  
Band:

Mayor Wilson said that the Village has a fund set up for celebrations and special events and that said monies had not been expended, following which she led a discussion about expending an amount to the Canaltown Days' Committee for the purpose of bringing the Mummers' Band to Palmyra for Canaltown Days, 9/82. An amount of \$500. was suggested. Trustee DePoint liked the idea if same could legally be done, and Mrs. McGrath said that the Village had brought other bands to Park for concerts. Atty. Poyzer stated that a "conditional resolution" may be passed by Bd., however, a call had been placed to Audit & Control for an opinion. Trustee Green felt that Bd. should wait until receiving such an opinion. Trustee DePoint moved that the Village expend the amount of \$500. toward bringing the Mummers' Band to Palmyra for Canaltown Days if it is legally within the Board's power to do so. Trustee McGrath seconded Mr. DePoint's Resolution #81-03. Roll call voting was as follows: Trustee Goulden - "aye"; Trustee DePoint - "aye"; Trustee McGrath - "aye"; with Trustee Green abstaining. "Conditional Resolution" #82-03 was passed by a majority and attached hereto.

Approv.:

Trustee Green moved that voucher amounts of \$34,151.63 be approved for payment; Trustee DePoint seconded. All voted "aye," motion carried.

ment:

There being no more business to come before the Board, at 8:05 p.m. Trustee DePoint motioned adjournment; Trustee McGrath seconded. All voted "aye," motion carried, following which Mayor Wilson said that citizens' questions would be entertained regarding tonight's Board Meeting.

RESOLUTION #82-01

Trustee Green moved passage of the following Resolution:

"WHEREAS, the Village Board has determined the need of assistance in the Village's annual budgeting process for the 1982-83 fiscal year, and

WHEREAS, Bernard P. Donegan, Inc., 27 Maple Avenue, Victor, N.Y. 14564 are specialists in the fields of budgeting and investment counseling,

NOW, THEREFORE, BE IT RESOLVED, that Mayor Mary Lou Wilson is hereby authorized to execute a Contract between the Village of Palmyra and Bernard P. Donegan, Inc., in the amount of \$3,300. plus out-of-pocket expenses, along with any other incidental costs in connection with the Village's budget and that the additional work beyond the scope of said Contract will be at the rate of \$55. per hour plus out-of-pocket expenses. The first billing shall be submitted at the regular March, 1982, Board Meeting, for one-half of the Contract amount, and the second billing shall be for the second half of the Contract shall be submitted for the regular Board Meeting in May, 1982."

Trustee Goulden seconded Trustee Green's motion for passage of Resolution #82-01, all voted "aye", motion carried and Resolution #82-01 unanimously adopted.

RESOLUTION #82-02

Trustee DePoint moved passage of the following Resolution:

"WHEREAS, by letter to the Village Board, dated December 28, 1981, Miss Helen Smith, 202 Canandaigua St., requested that the sewer units at her residence be reduced from four to three units permanently, and

WHEREAS, the Board stated that a resolution in this regard would be irrevocable inasmuch as this residence is in an R-1 Zone,

NOW, THEREFORE, BE IT RESOLVED, that the sewer units at the above premises are hereby reduced from four to three units, thereby reducing the overall sewer rate from \$84. per quarter to \$63. per quarter, effective March 1, 1982.

Trustee McGrath seconded Mr. DePoint's motion to adopt the foregoing Resolution; all voted "aye," Resolution #82-02 unanimously adopted.

RESOLUTION #82-03 ("CONDITIONAL")

Moment of Silence: Mayor Wilson requested that a moment of silence be observed prior to conducting business of the Board.

Minutes: Trustee Green moved acceptance of the 1/4/82 Minutes, following Mary Lou Wilson's having asked if there were any corrections or additions and there were none. Trustee Goulden seconded acceptance of the Minutes; all voted "aye," motion carried.
- Grievance  
Day: Mayor Wilson stated that assignments and hours must be set for Grievance Day on 2/16/82 and a discussion was held on where same would occur. Assessor Roney had reserved the Masonic Temple and a suggested honorarium. Following discussion, the Board agreed that Grievance Day should be held in the temporary Village Hall, 149 E. Main St. from 4:00-6:00 p.m. and 7:00-9:00 p.m. and, perhaps, employees could be dismissed early. Board members to attend the Board of Assessment Review Sessions are as follows: 4:00-6:00 p.m. - Trustees Green, DePoint and Goulden; 7:00-9:00 p.m. - Mayor Wilson and Trustee McGrath.

Assessment  
Roll: Mayor Wilson announced that Assessor Roney had informed her and a Legal Notice placed in the official newspaper that the Tentative Village Assessment Roll would be available in the Village Office from 1/28/82-2/16/82, for citizens' examinations and review. Legal Notice attached hereto.
- Fire &  
Bldg.  
Codes: Mayor Wilson read excerpts from a communication received from Ms. Sharon T. Lilla of the Wayne County Planning Board regarding a New York State Uniform Fire Prevention and Building Code. Since the Village of Palmyra has adopted the New York State Building Construction Code, the Fire Code need not be adopted by 3/1/82 as required by the State. Mayor Wilson emphasized that the Village of Palmyra is in compliance, however, this is not to say that we shouldn't adopt the Fire Code.
- UR  
Monies: Trustee Green said that he had a letter from Atty. Paul Rubery regarding Urban Renewal monies and that Mr. Rubery would be calling a person at HUD for giving the Village direction in this matter. Mayor Wilson added that Sharon T. Lilla of the Wayne County Planning Board had offered her assistance in this matter, having called HUD also. Ms. Lilla said that procedure is a fairly simple one - itemizing escrow account, state that there had been no activity, file balance sheet as well as number of other forms, and that there is no time limit of using monies, according to HUD representative. Ms. Lilla volunteered to come to Bd. Mtg. to relate her findings. Trustee DePoint felt the above should come to the Bd. in writing.
- Water  
Leak: Trustee DePoint spoke of a water leak on Vienna Street and the replacement of a shut-off valve. He added that plans are being made to accomplish work or replacement of the Vienna St. water line. It was stated that Lozier's Engineers had placed a communication in the mail regarding their recent proposal which was accepted by the Board.
- Cemetery: Trustee Goulden said that he had nothing to report since the Cemetery is closed for the season.
- Community  
Center: Trustee DePoint said that he had received the timely budgetary request from Director J. Campbell of the Community Center. Said request amounts to \$13,500. and will be considered by the Board in its budget preparation. Discussion ensued regarding amts. given by the Town and Village, comparatively speaking.

Dept.: Trustee DePoint said that, according to Chief Henry, the Police Dept. is running smoothly. He spoke of having received evaluations on probationary patrolmen which were extended from eight to 26 weeks.
- Town -  
Water: A proposed meeting with the water rep. on the Town Bd. was related by Trustee DePoint regarding the projected water needs for the Town/Village. He said that he hoped to resolve problems with north and south master meters latter part of wk. As a point of information regarding the P.D., Mr. DePoint said that two P.D. Patrolmen shall be attending Breathalyzer Sch. on 1/26/82-1/29/82; and that Chief Henry shall be operating night P.D. shifts to instruct new Patrolmen, I.e. alternating for next two weeks.

Hall  
Renova.:

Trustee McGrath talked of her disappointment in the lack of progress on the Village Hall renovation in that there had been no activity for past week - the person working on the heating plant had been only person working. She said that insulators, people who are to do dry walls, etc. had certain work to perform before person doing heating work could complete his work. Discussion held on payment vouchers and that same would be held up. Trustee DePoint looked over Thornwood Contractor's Contract and stated that completion date was projected for 3/31/82. Discussion was also held on bid that was awarded Thornwood for outside roof and gutter work and no Contract having been received. Trustee DePoint suggested contact be made by letter for documentation. Mrs. McGrath stated that a supervisor had not been present on the Village Hall renovation job since it had begun.

Village  
Map:

Trustee McGrath said that Fire Dept. unhappy with present Village Map - perhaps it should be updated. W&WW Supt.'s map more thorough but too large to serve their purpose. No action taken.

Fire Dept.  
Applica.:

Fire Dept. Application for Michael Lee Winston of Canandaigua Rd. was presented by Mrs. McGrath for Bd. approval. Another Application for James Otto of Walker Rd. requesting reinstatement since he had lived out-of-town was discussed by the Bd. but rejected since it did not contain three Fire Commissioners' signatures. The Clerk was asked to return same. Trustee DePoint moved that the Bd. approve the Application of M. L. Winston; Trustee McGrath seconded. All voted "aye," motion carried. Discussion followed when Trustee Green asked if Firemen are required to have physical exams prior to acceptance, and his concern about liability. He said that perhaps this was something Village had overlooked for years. It was stated that certain questions regarding health appear on Fire Dept. Applications and that Firemen are eligible for Workmen's Compensation. The question arose that if one can't work because of a disability, how could one be an active Fireman. No action taken other than discussion.

Rink:

Trustee McGrath said that the ice skating rink is functional, however, there may be other areas of concern there such as hours, lights on at night, etc.

Mrs. Heatherly, art teacher at Pal-Mac, had been contacted regarding the painting of historic scenes in hallway of renovated Village Hall, stated Mrs. McGrath.

February 1, 1982

7:00 p.m.

Present: Mayor Mary Lou Wilson; Trustees Lloyd Green, Mary Kay McGrath and Fred Goulden; and Atty. Poyzer. Absent: James I. DePoint, Trustee.

Call to Order: At 7:03 p.m. Mayor Wilson called the meeting to order and requested a moment of silence.

1/18/82 Minutes: Mayor Wilson asked for additions or corrections to the 1/18/82 Board Minutes. When there were none, Trustee Green moved approval; Trustee Goulden seconded. All voted "aye," motion carried.

Voting Precinct: Discussion was held on the designation of a voting precinct for the 3/16/82 Village Election. The Clerk was asked to check on the legality of holding same in the temporary Village Office at 149 E. Main St., where Registration will be held; and alternate sites - Masonic Lodge & the Presbyterian Church, were mentioned as possibilities. The Clerk was requested to call the Presby. Church since Mrs. M. Lawrence said that a Voting Machine was already placed there. Also discussed was the suggestion that the office could be closed from Noon to 5:00 p.m. should voting occur in the P&C Rms. Determination to be made at next regular Bd. Mtg.

Personnel Evaluation: Personnel evaluations were discussed and it was emphasized that these should be accomplished soon.

Congress, Horton: Mayor Wilson said that Congressman Frank Horton would be visiting Wayne County constituents on Sat., 2/13/82 having scheduled his Palmyra visit from 9:00 a.m. Noon at the Town Office Bldg., 201 E. Main St.

Highway Dept.: Trustee Green said that he had nothing to report in this area.

Cemetery: Trustee Goulden, likewise, had nothing to report regarding the Cemetery.

Fire Dept. Applica.: Trustee McGrath stated that the Application for membership from Mr. James Otto had been re-submitted with the proper number (3) of Fire Commissioners' signatures. She motioned his acceptance; Trustee Goulden seconded. All voted "aye," carried.

- Village Hall Renova.: Trustee McGrath spoke of the need for a larger heating unit (salamander) prior to drywalling, and that in the Contract, Village supplies heat in Village Hall. Discussion held and the Clerk requested to have Assessor Roney ascertain ownership of same.

Mrs. Bradish also requested that the rustic directional signs be updated in her area. Discussion held and it was related that Trustee DePoint had volunteered to assume the responsibility on all of the Village's rustic signs. The Clerk was asked to research the matter and find out from W&WW Supt., H. Kruger, on charges, etc. from Miller Signs in Newark who had accomplished said work on signs at Sewer Plant.

UR Funds  
(Sharon  
Lilla):

Mayor Wilson introduced Ms. Sharon Lilla of the Wayne County Planning Board who has expertise in various grants and who had previously completed the Application to Historic Preservation regarding the Village Hall.

Ms. Lilla said that the HUD contact person was Mr. John Lang - that she also talked with Atty. Paul Rubery regarding unexpended UR funds. Recapping past funding and expenditures, she spoke of \$890,995. grant, \$824,754. of which was spent, creating a surplus of \$66,241. which was used in building the Community Center. Of the \$128,661. allowed for UR closeout costs, said cost amounted to \$101,381., thus creating an additional surplus of \$27,280.

She was instructed that Village should submit balance sheet explaining where money came from, i.e. reason for surplus - how surplus came about. Balance sheet should be sent to HUD, following which they will approve or return for re-submission. Form 718 should be sent to N. Y. Office to reserve what is in escrow in N. Y. City. Check will then be sent to HUD in N.Y. City explaining why Village has surplus. Village, in meantime, can be making out Community Development Grant Block Application - Ms. Lilla suggested that a pre-application may be the method to use. State was to have taken over the program, however, HUD continuing for one year. She emphasized that guidelines will be unknown until 3/30/82 - application may be made in three areas: 1) Community facilities; 2) Housing rehabilitation, and 3) Economic redevelopment. Basic objective to benefit low and moderate income persons. A target area is important - Highway Barn desired, however, she felt HUD would not acknowledge same. Reducing neighborhood blight would be objective - Trustee Green asked what would occur if Highway Barn area is the Village's blight area.

Ms. Lilla stated that the Village could increase amount as long as it is in pre-application; Village can spend more than \$30,000. - that amount guaranteed anyway - Village may have to match amount. She spoke of competitiveness, municipal incentives, front money, all of which look good in program when Village willing to help itself. She requested Form 6204, dated 3/30/76, from the Clerk which outlines what close-out money was to be used for. Estimates off by \$28,000. Discussion held on Village properties adjacent to Village Barns which runs parallel to Canal St. down as far as Blazey's. Ms. Lilla continued discussion on rental rehabilitation incentives for landlords to fix up rental units; low interest rate loans

Cont'd: for low income families in order to qualify for a grant - income guidelines gone up to approx. \$16,000. now; Section 8 funds are gone; setting up program whereby offer rehab. of rental units and landlords must agree to rent to low and moderate income people for "x" number of years.

Trustee Green felt that Ms. Lilla's explanation was the first time it was ever made clear where excess UR money came from, etc. Mayor Wilson thanked her for coming, and added that she will be working with Village Planning Board regarding Zoning revisions in near future.

Request: Mayor Wilson said that Assessor Roney requested permission to spend \$400. on file folders for an odd-sized filing cabinet he utilizes - and that he does have money remaining in his budget. The Board agreed to this expenditure.

"WHEREAS, the Democratic Party has suggested the names of Mrs. Nora O'Brien and Mrs. Marjorie Lawrence, and the Republican Party has suggested the names of Mrs. Elizabeth Schrader and Mrs. Helen Parsons, to be Election Inspectors for Registration Day, February 27, 1982, and for Village Election on March 16, 1982, at a minimum wage salary of \$3.35 per hour,

NOW, THEREFORE, BE IT RESOLVED, that the above shall be so notified that they have been appointed for a period of one year to serve as Election Inspectors and the 'Oath of Office' shall be administered by the Clerk to each appointee."

Trustee McGrath seconded adoption of the foregoing Resolution; all voted "aye," Resolution #82-05 unanimously adopted.
