Present:

James G. Elliott, Mayor; Trustees Daniel E. Wooden & Thomas N. Lynch & Village Atty., John B. Nesbitt, Esq. (Trustee Charles D. Gilmore arrived @ approx. 8:10 p.m.). Absent: Trustee Daniel S. Pope III.

Call to Order:

Mayor Elliott called the meeting to order @ 7:08 p.m., following which he acknowledged several citizens who were present.

Shock Incarcaration clients to clean the VOP creeks.

Meeting With E. Foster St. Residents/Town & Village Boards:

Following a discussion re the drainage problem on E.
Foster St., a determination was made by the VB to
conduct a meeting among the Village & Town Bds. &
the residents involved @ 7:00 p.m. on Monday,
7/22/91, in the Trustees' Rm. of the Village Hall.
Mayor Elliott said that no word received from
authorities re the VOP's request for the WC Butler

Mill Street Residents' Comments in Support of Mr. M. Poretta (re M/M J. Bettinger's Complaints):

Mr. Poretta stated that Mr. Bettinger "having trouble with neighbors on Mill St. causing a lot of trouble"....to which Mr. B. replied, "only one neighbor because his facility was illegal"....no 'grandfather clause' he said...the disagreement and discussion between the two parties was called to a halt by the Mayor - should address the VB, he said, and no one had made request for Agenda placement. M/M Bettinger departed early in the discussion. Approximately 15 persons were present in support of Mr. Poretta, many of whom had favorable comments about his operation and several long-term residents who spoke of the improvement in the area since Mr. P. bought the shop @ the corner of Mill & Vienna Sts.

Following the above, Mrs. Gail Ruliffson asked about the traffic light on E. Main (Johnson's Pharmacy) and the dangers - lanes were marked, why removed? Chief Dalton explained apparent lack of communication between State DOT & VOP....discussion on reinitiating matter with DOT. Mayor Elliott then moved that the VOP request from State DOT to place traffic light signs and markings and send the VOP's original request as an attachment to the request. Trustee Lynch seconded; voting "aye" were Mayor Elliott and Trustees Lynch & Wooden. Carried.

Town -Cleanup:

Mr. Mike Janokitz stated that the Town determined to hold a "summer cleanup" limited to scrap metal and tires only and would allow the VOP to participate in same. Date for cleanup to be determined.

Minutes:

Since all Bd. members had not had the opportunity to review the Minutes, Mayor Elliott moved tabling of the following Minutes (but that they be made available to the public): Regular Meeting, 6/17/91; Infor- mal and Spec. Mtg., 6/24/91 re Medical Facility on W. Main St. & Union Neg. Mtg., 6/27/91. Trustee Wooden seconded. Voting "aye" were Mayor Elliott & Trustees Wooden & Lynch. Carried.

New Police

Car:

Police Chief Dalton asked the VB about purchasing a new P.D. car @ State bid price @ a cost of \$14,403. delivered (\$16,000. budgeted). VB discussed and Mayor Elliott moved that the VOP purchase a 1991 Police car from Warnock, Inc. which meets State bid specifications; also expend an amount not to exceed \$1,000. for adapting and labor to change cage and lightbar, radios and place VOP emblem on said car. Trustee Lynch asked about 'other' cars, mileages, and could cars in use presently last another year. His opinion that the VOP does not need another P.D. car. More discussion. Trustee Wooden seconded on the basis of amendment.... "not to exceed \$14,403." VB agreed that upon arrival of new car, determination to be made whether or not to dispose of old car and if so, how. Voting "aye" were Trustees Wooden, Lynch & Gilmore. Carried. Mayor Elliott did not register a vote.

Creek - Brookside Terrace:

Trustee Lynch stated that Mr. R. Lewis of Brookside Ter. in office to complain of creek - full of debris causing creek to back up...stagnant...mosquitos bad. VB discussed - Hwy. Supt. requested to visit site and do the best job Hwy. could do with the stoppage, etc. - a one time only effort the Bd. said.

Sludge:

Trustee Wooden stated that W&WW Employee, Carlton Timerson, had checked into disposition of sludge having located a company out of Buffalo that will pick up and haul dry sludge @ a cost of \$55. per ton to haul plus \$600. hauling charge....\$2140. to get rid of 30 yrds. (equivalent to five loads)...cost \$2800. to get to Seneca Meadows...checking into incineration...have to get permits, too.

Citizen Karlene Freyn spoke of an accident on Vienna St. prior Sunday night - and the dangerous/potential of serious accidents in said area; discussion on resolutions..."Stop" line at the end of Vienna St. - three-way stop...take "Stop" sign down from Prospect Dr., following which Trustee Wooden moved that the Police Chief be authorized to investigate possibilities for a solution; Mayor Elliott seconded adding three-way stop or through street on Vienna - or best solution....Voting "aye" were Trustees Wooden & Lynch & Mayor Elliott. Trustee Gilmore voted "nay." Carried by majority.
