

VILLAGE OF PALMYRA BOARD OF TRUSTEES

Regular Meeting

Sept. 7, 1993

7:00 p.m.

**PRESENT:** Mayor James G. Elliott, Deputy Mayor Thomas N. Lynch, Trustees Daniel E. Wooden and C. D. Gilmore. Trustee Kathleen C. Drews arrived at 8:15 p.m. Attorney J. Nesbitt arrived at 8:20 p.m. Chief David Dalton and W/WW Superintendent H. Kruger were in attendance.

**CALL TO ORDER:** Mayor Elliott called the meeting to order at 7:10 p.m. with a moment of silence for Mr. Ronald Kommer owner and operator of the Central Newsroom and Mrs. P. Wilson, one time owner and operator of the Palmyra Bakery. Both have been long time business persons of the Village of Palmyra.

**MRS. WELDA DeBROWN:** Scheduled for 7:00 on the agenda was ill and did not attend.

**MINUTES:** Trustee Gilmore moved to accept the minutes of regular meetings August 2, August 16, and special mtg. Aug. 30, 1993, seconded by Trustee Wooden, vote 3 ayes, Deputy Mayor Lynch abstained. **CARRIED 3-1 abs.**

**YEAR BOOK ADS:** Mayor Elliott reported that A. Bogen of the Pal-Mac year book committee was asking if the VB would be interested in placing an ad in the year book as done last year. Last ad said GOOD LUCK w/VB members names. Trustee Gilmore thought that the VB could be more creative with wording. This is done by the VB members personally.

**BUDGET TRANSFER:** Mayor Elliott moved to make the following transfer of \$350 for the mailing of a questionnaire regarding the master plan survey from Contingency A1990.4 to Planning A8020.4, seconded by Trustee Gilmore, Mayor Elliott explained that the \$350 goes to the Post Office for business replies including a permit, vote, 4 ayes, **CARRIED.**

**ABSTRACT #7:** Mayor Elliott moved to authorize the Village Treasurer to pay vouchers #332 through 383 totalling \$31,258.57 and voucher #321 for \$185 on which appear the initials of three (3) Village Board members, seconded by Trustee Wooden, vote, 4 ayes, **CARRIED.**

**FIRE ALARM SYSTEM AND WATER ALARM:** Mayor Elliott reported that there is a \$45.65 mileage charge for a line from the Water Plant to the Village Hall to alert a problem at the Water Plant. For approx. \$500 a dialer could be installed which would do the same job and eliminate the monthly charge. This would pay for itself in about 1 year. Mayor Elliott will get some prices.

**LTR. FROM TOWN OF PALMYRA ON SEWER LINES OUT DIVISION ST.:** A letter was received from the TOP asking for a mtg. between the TOP Bd. and the VB to discuss sewer capacity and hook into VOP sewer line. A developer is interested in developing the airport and would like sewer. Mayor Elliott noted a mtg. time needed to be decided and suggested next VB meeting. Trustee Gilmore voiced concern about the VOP having enough and being covered totally. Mayor Elliott noted that about 60% of capacity being used now, this TOP hook <sup>up</sup> would give the VOP additional revenue and about 1000 units could be added to the sewer system.

**CANALTOWN DAYS STREET AND PARKING RESTRICTIONS:** Mayor Elliott moved and Trustee Gilmore seconded that the following streets and locations have parking restrictions and that the American Legion be allowed to close Cuyler St. in front of the Legion from 7-9 p.m. Saturday, Sept. 18, 1993, for musical entertainment.

**CABLE TV:** Mayor Elliott reported a ltr had been received to let the VOP, Cable TV, or Public Service Comm. regulate local rates. The VB has not received the rules and regulations as of yet and no motions were made. Mayor Elliott noted that the WCVO mtg. was going to have a speaker on Cable TV also a mtg. in Walworth at 7:30 p.m. on Friday, Sept. 10, 1993, would discuss Cable TV.

**VEHICLE AND TRAFFIC LAW:** Mayor Elliott proposed changes to the Vehicle and Traffic Law. Discussion followed concerning the changes proposed and other suggestions as follows: Restricted parking on both sides of Canal Street, not allowing any parking within 30' of any corner (needs to be marked). Paint restrictions in road instead of more signs suggested Trustee Wooden. Mayor Elliott and Chief Dalton noted that in winter weather conditions can't see also maintenance will be continual. Signs will be cheaper than painting. Handicap parking on Main St. on each corner instead of middle of the block as now. The handicap parking on corner of Cuyler and Main at Johnson's is difficult to get out of door. Neither handicap parking at Marine Midland or Zion Ep. Church are in ordinance.

There is not supposed to be any parking in front of the Post Office, it is now marked for handicap. Suggested from Nesbitt's driveway to the Legion should be for handicapped. Suggested temporary parking on Sunday, Chief and Mayor agree should have or not have parking. Mayor Elliott will check with S. Lane of the Episcopal Church to see if they want handicap parking (official).

Chief Dalton noted that a Village resident asked if there could be no parking on any of the Village streets during 2 am to 6 am throughout the year vs only winter restrictions.

Blazey's letter and request for paving area on Canal for parking was checked out by Mayor Elliott and Chief Dalton. Mayor suggested that the law be amended to allow parking on the northside of the Blazey bldg. as requested.

Suggested to make all streets no parking on at least one side. No parking at all on Prospect Drive.

**JACKSON STREET WATERLINE AND PAVING:** Deputy Mayor Lynch checked into prices for curbing, sidewalks, etc. Granit curb is about \$86,000, concrete curb \$100,000, sidewalks \$75,000. Approx. street, sidewalk, and curb \$250,000.

**DRAINAGE:** Deputy Mayor Lynch reported that John Webler of Sneider Assoc. will look at the area between Gates and Tremont Strs. at 1:00 p.m. tomorrow.

**FIRE DEPARTMENT APPLICATION:** A motion was made by Trustee Gilmore and seconded by Trustee Wooden to accept the fire dept. application of James Scott MacDuff for membership upon the completion of a satisfactory physical by the Village physician, vote, 4 ayes, **CARRIED.**

**REPAIRING CUYLER ST. CULVERT:** Deputy Mayor Lynch reported that the Highway Dept. was repairing the culvert on Cuyler Street. Should be done by Canaltown Days.

**EXECUTIVE SESSION:** Mayor Elliott moved at 8:20 p.m. to go into executive session for matters of personnel, union negotiations with the VB and those employees of the Village as called in, seconded by Trustee Wooden, 4 ayes, **CARRIED.**

Trustee Gilmore moved out of executive session at 11:15 p.m. seconded by Mayor Elliott, vote, 4 ayes, **CARRIED** Deputy Mayor Lynch out of the room.

**ADJOURNMENT:** Mayor Elliott moved to adjourn the meeting at 11:15 p.m. seconded by Trustee Gilmore, vote, 4 ayes, **CARRIED.** Deputy Mayor Lynch out of room.
