ARTICLE I
Speed Restrictions

§ 183-1. Definitions.

The words and terms used in this chapter, unless otherwise expressly stated, or unless the context or subject matter otherwise requires, shall have the same meanings as defined in the Vehicle and Traffic Law of the State of New York.

§ 183-2. Maximum speed limits.

- A. Thirty miles per hour is hereby established as the maximum speed at which vehicles may proceed on or along highways within the corporate limits of the Village of Palmyra, except on the following:
- (1) On the portion of Hyde Parkway as more particularly described in Subsection B of this section during times stated in said Subsection B.
 - (2) On the portion of West Foster Street as more particularly described in Subsection B of this section, during the times stated in said Subsection B.
 - (3) On the portion of Canandaigua Street as more particularly described in Subsection B of this section, during the times stated in said Subsection B.
- B. Twenty miles per hour is hereby established as the maximum speed at which vehicles may proceed during school days between the hours of 7:00 a.m. and 6:00 p.m. on or along the following highway areas:
- (1) Hyde Parkway from a point 300 feet north of the intersection of the north building line of the Palmyra-Macedon Senior High School Building, as said building line is projected easterly with the west boundary of Hyde Parkway, to the intersection of Hyde Parkway and West Foster Street.
 - (2) West Foster Street from its intersection with the east boundary of Hyde Parkway east for a distance of 300 feet.
 - (3) Canandaigua Street from a point 300 feet north of the intersection of the north building line of the Palmyra Elementary School, as said line is projected westerly, with the Canandaigua Street east boundary, to a point 300 feet south of the intersection of the south building line of the Palmyra Elementary School, as said line is projected westerly with the Canandaigua Street east boundary.
- C. Notwithstanding the foregoing, no person shall drive a vehicle at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing.

**ARTICLE II
Directional, Stop and Yield Restrictions**

§ 183-3. One-way streets.

The following streets or parts of streets are hereby designated as one-way streets in the direction indicated:

§ 183-5. Traffic control signals.

The intersection listed below is hereby designated as controlled by a flashing traffic control signal as defined in § 1113 of the New York State Vehicle and Traffic Law. The flashing yellow indications shall control traffic upon the first mentioned street, and the flashing red indications the second. Traffic control signals shall be erected in conformance with the New York State Manual of Uniform Traffic Control Devices (Chapter II of Title 15 of the Official Compilation of Codes, Rules and Regulations of the State of New York), adopted pursuant to § 1680 of the New York State Vehicle and Traffic Law.

**ARTICLE III
Parking Restrictions**

§ 183-7. Parking or standing prohibited. [Amended 8-15-1998 by L.L. No. 4-19-1988; 2-6-1989 by L.L. No. 2-1989; 1-4-1993 by L.L. No. 1-1993; 11-17-2003 by L.L. No. 2-2003; 12-20-2004 by L.L. No. 3-2004; 5-3-2010 by L.L. No. 4-2010; 8-6-2018 by L.L. No. 1-2018]

The parking or standing of vehicles in any of the following locations is hereby prohibited:

- A. On all Village streets between the pavement edge and sidewalk or, on streets without public sidewalks, for a distance of five feet from the pavement edge.
- B. It shall be unlawful to park any trailer, tractor, tractor-trailer; house-trailer, recreational vehicle, motor home, farm equipment, tow truck, utility trailer or construction vehicle (including but not limited to cement mixers, dump trucks, heavy equipment loaders, bulldozers, diggers, and front loaders) along and upon either side of any residential street in the Village of Palmyra at any time. "Tractor-trailer" is defined as a combination trucking unit consisting of a tractor hooked up to a full trailer or semitrailer, including but not limited to a rig, semi, trucking rig, lorry, motor truck, semitrailer and/or tandem trailer.
 - (1) Exception. Those vehicles, trucks and/or trailers temporarily parked along a roadway utilized while performing a service or job, such as lawn mowing, driveway sealing or driveway paving, shall be exempt from this section.
 - (2) The purpose of this Subsection B is to protect the health, safety and welfare of the public, as parked tractor-trailer vehicles on residential streets prevent other drivers, pedestrians and bicyclists from seeing around them and they diminish the street space available for other passing motor vehicles, pedestrians and bicycles.

§ 183-8. Two-hour parking. [Amended 6-6-2005 by L.L. No. 2-2005]

No vehicle of any description shall be continuously parked for a period of two hours between the hours of 8:00 a.m. and 5:00 p.m., prevailing time, any day of the week but Sunday, with the exception of the following holidays: New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, and Christmas Day, in the following locations:

§ 183-10. Prohibition of all-night parking. [Amended 11-17-2003 by L.L. No. 2-2003; 12-20-2004 by L.L. No. 3-2004]

- A. No vehicle shall be parked on any public highway within the corporate limits of the Village of Palmyra between the hours of 2:00 a.m. and 7:00 a.m. during the period beginning November 1 and ending March 31 of each year.
- B. No parking 2:00 a.m. to 7:00 a.m., 12 months of the year: East Main Street from Route 21 to Clinton Street.

§ 183-11. Prohibition of parking during special events.

- A. In addition to and notwithstanding any other provisions of this chapter permitting or prohibiting parking, the stopping, standing or parking of vehicles upon any street or portion thereof or public area, except state highways, within the Village of Palmyra may be prohibited by resolution of the Board of Trustees of the Village of Palmyra for such period of time as is required, in the opinion of the Board of Trustees, to provide for the safe passage of vehicles, pedestrians and/or emergency vehicles.
- B. A resolution adopted by the Board of Trustees pursuant to this section shall designate the area, street or portion thereof within which the stopping, standing or parking of vehicles is prohibited and the period of time of such prohibition.
- C. If a resolution is adopted by the Board of Trustees pursuant to this section, the Board of Trustees shall direct posting of temporary signs or markings in the area affected in accordance with the applicable provisions of the Vehicle and Traffic Law of the State of New York, and such resolution shall not take effect until signs or markings giving notice thereof are posted.

§ 183-12. Regulations for Village parking lots.

- A. The standing or parking of any vehicle for a period in excess of 24 hours in any parking lots owned by or under the control of the Village of Palmyra is hereby prohibited.
- B. The repair or maintenance of any vehicle parked or located in any parking lots owned by or under the control of the Village of Palmyra is hereby prohibited.

§ 183-12.1. Regulations for boat docking. [Added 10-3-2005 by L.L. No. 6-2005]

- A. The docking of boats, yachts or other floating craft anywhere within the Palmyra

marina for more than 48 hours is prohibited, unless extended by written permission from the Village of Palmyra.

- B. Any person violating this section of this chapter shall, upon conviction, be sentenced to a fine of \$50 for a first offense and a fine not to exceed \$100 for any subsequent offenses.

**ARTICLE IV
Handicapped Parking**

§ 183-13. Designated areas. [Amended 1-4-1993 by L.L. No. 1-1993; 5-3-2010 by L.L. No. 4-2010]

A. The stopping, standing or parking of any vehicle, except for a vehicle which bears a handicapped parking permit issued pursuant to § 1203-a of the New York State Vehicle and Traffic Law or a registration issued under § 404-a of the New York State Vehicle and Traffic Law and such vehicle is being used for the transportation of a handicapped person, is prohibited in the following areas:

B. Spaces specified as parking and stopping places for handicapped persons shall be marked and indicated by suitable stationary signs indicating the location and extent of such places so reserved.

§ 183-14. Issuance of permits.

Pursuant to § 1203-a of the Vehicle and Traffic Law of the State of New York, the Chief of Police of the Village of Palmyra is designated as the issuing agent of permits for the handicapped.

A. The issuing agent shall issue permits for handicapped parking upon his receipt of a completed application executed by the handicapped person, or by the parent or

guardian of a minor handicapped person, upon a form to be provided by the issuing agent, provided that said application shall be accompanied by a medical certification relating to the applicant or such minor child, which certification shall be made by a physician licensed to practice medicine in the State of New York and which certification shall establish that the applicant or such minor child is qualified to receive such permit pursuant to the qualifications set forth below.

- B. A person shall be qualified to receive a handicapped parking permit if such person:
- (1) Has limited or no use of one or both lower limbs;
 - (2) Has a neuromuscular dysfunction which severely limits mobility;
 - (3) Has a pulmonary or cardiovascular condition which limits mobility or severely limits the individual's activities in the open air; or
 - (4) Has a physical or mental impairment or condition, other than those specified above, but of such nature as to impose an unusual hardship in connection with physical mobility so as to render it medically desirable that such person is permitted to use handicapped parking facilities, if such condition is certified by a physician duly licensed to practice medicine in New York State as constituting a degree of disability (specifying the particular condition) equal to those set forth in the preceding subsections hereof so as to prevent such person from having physical mobility as a pedestrian without great difficulty.
- C. Each permit issued hereunder shall bear the license plate number of those vehicles in which the handicapped person customarily rides. The application shall also be accompanied by valid New York State registration certificates for each of said vehicles.
- D. The permit to be issued shall be in the form of a sticker to be provided by New York State pursuant to § 1203-a of the Vehicle and Traffic Law, which sticker shall be affixed to each vehicle for which the registration is included in the application. Each such sticker or permit shall expire upon the expiration date of the registration certificate concerned, but shall be renewed upon an application accompanied by the renewal registration certificate for any succeeding period of time or by a valid registration certificate for any other or different vehicle which the applicant or his parent or guardian shall certify as being a vehicle in which the applicant customarily rides.

§ 183-15. Revocation of permits.

The issuing agent may suspend or revoke any permit or refuse to renew any permit upon a finding that:

- A. The applicant has made a material false statement in the application;
- B. The applicant has used or permitted the use of the permit contrary to conditions set forth in the permit and in this chapter;
- C. The applicant has failed to comply with or observe any of the conditions of the application and/or of the permit; or

- D. The applicant shall have failed to have notified the issuing agent of any change of address or disability within 10 days after such change.

§ 183-16. Hearing upon denial, suspension or revocation of permit.

Upon denial of an application for a permit or a renewal or upon a suspension or revocation of a permit, the applicant may make written request for a hearing. The issuing agent shall grant such hearing, to be held before him, within 10 days after his receipt of such written request. The written request must be filed with the issuing agent no later than 30 days following notification of the applicant of the action as to which the hearing is requested. The issuing agent shall in any event notify the applicant within 21 days after receipt of the completed application as to its approval or disapproval. If the application is disapproved, a statement setting forth the reasons for disapproval shall be provided.

ARTICLE V
Enforcement

§ 183-17. Penalties for offenses.

Any person violating any of the provisions of any of the sections of this chapter shall, upon conviction, be punished by penalties not to exceed the maximum penalties for similar offenses provided in the Vehicle and Traffic Law of the State of New York. In the event there is not a similar offense therein provided, the maximum penalties set forth in § 1800(b) of the Vehicle and Traffic Law of the State of New York shall apply.
