Present:

Warner H. Strong, Mayor; Trustees James G. Elliott, Penelope K. Frontuto & Charles D. Gilmore; & Village Atty., John B. Nesbitt. Absent: Trustee John Vrubel.

Moment of Silence:

The Mayor requested a moment of silence during which time he requested that those present remember Fire Chief Roger Ruebens' mother, Mrs. Ray (Dorothy) Ruebens, who passed away prev. wk.

Agenda:

Mayor read "Agenda" motion passed by the Bd. during 4/13/87 mtg: It was stated that Water & Sewer Relevy resolution had been added. Bd. accepted sd. addition wherein Village adds unpd. water & sewer bills as of 4/30/87 to prop. owners' taxes.

Pub. Hrng. The Mayor requested the Clk. to read legal notice prior to LL#2, '87: opening public hearing on Local Law #2, 1987, re amending Chapter 27, "Water Service," of the Code of the Village of Palmyra. Mayor Strong stated that he had problem wth. Sect. 27-11 which states that "a member of the Board of Trustees of the Village of Palmyra and any official or employee of the Village of Palmyra may, at any time, enter any building..... re inspection of premises. Homeowners, he sd., have no protection, anytime - seven days a week - wld. rather see it read.... "W&S Dept./Trustee-in-Charge.... during normal hrs." Trustee Elliott felt it shld. include Highway Supt. whose dept. does the work. He had problem wth. "during normal hrs." - doesn't always happen during He had problem "normal hrs." Mayor felt shid. be changed re "anytime - day or night." Mr. Elliott sd. in current law; Mayor sd. verbage shid. be removed...he added inspecting the pipes in event of major leak(s)...shid. not allow just "anybody" access. Mr. Elliott sd. it shid. include W&S Supt., Hway & Trustee-in-Charge - H. Kruger in chrg. of Water Dept., however, P. Retan, HWay Supt. in charge of "workers." Mr. Gilmore felt Bd. shld. look at something by way of permission - all possible steps of notifying the homeowners. Mayor sd. "under emergency condition(s)" - some restriction.
"Emergency repair of leaks," per J. Elliott. He sd. that P. Retan wldn't go anyway unless Chief Henry went with him. More disc. re proposed changes. Bd. agreed. Sect. 27-11 to read.... Inspection of Premises. The W&S Supt., Trusteein-Charge & Highway Supt. may enter any building or upon any premises where water service is furnished by the Village of Palmyra for the purpose of making any examination of the pipes, fixtures, equipment or meter for repair of leaks in an emergency." Lst. two lines of prior section, Sect. 27-9 contains typo - change frm. "said freezing and thawing"....to "said freezing and/or thawing."

> The Mayor asked if there were questions frm. public - when there were none the Mayor read "Schedule of Rates & Charges." At 7:20 p.m. the public hearing was closed upon a motion by Trustee Frontuto; Trustee Elliott seconded. Voting "aye were Trustees Frontuto, Elliott, &Gilmore. Carried. The Mayor declared the public hearing closed.

Replacement only if there is a problem, per Mayor. Per Mr. Elliott, contract wth. homeowner when put in, thereafter Village maintains. Bd. to get clarification frm. Atty. Nesbitt re Sect. 27-11 for 5/18/87 Bd. Mtg.

Citizen D. Mr. D. Pettengill, having filed application for Village position of "Code Enforcement Officer", approached the Bd. stat-Pettengill: ing that someone said they saw the applications; why would someone want to see the application(s) - and what will be done to prevent this frm. happening again. There is private information on the apps., he sd. The Mayor asked the question that someone reviewed his application? Mayor sd. applications are confidential/reviewed by Trustees - disc. on folder of apps.' placement (by Trustees' mailboxes) - placed there since lst. mtg., per Trustee Frontuto; Trustee Gilmore sd. may have been corrected already; Mayor sd. they shid. not have bn. ift. out; Trustees shid. have gone to file - procedural error/confidential data. Hereafter, Trustees, will have to go to Vill. Clk. to get data/cannot be lft. out for easy review; copying of applications shld. be stopped/shld. go into personnel file setting/hve. to address that question/shld. not have been reviewed by anybody but Trustees, etc. Mayor apologized to Mr. Pettengill; Trustee Gilmore sd. whole Bd. owed him an apology. Disc. discontinued.

Bids/Sewer Engineer D. Means was present @ 7:30 p.m. for disc./possible Plnt.Proj: bid award re bid opening @ 2:00 p.m., 5/1/87 - Sewer Plnt. Proj. The bids were as follows: General - Hubbard Const., \$522,522.; Over & Under, \$744,179.; Electrical - Hendler Elec., \$17,670.; Martlin Elec., \$18,482.; Maher Elec., \$20,500.; S. R. Bacher Elec., \$24,614. Apparent low bidders: Hubbard Const. (Gen.) - \$552,522.; and Hendler Elec. (Elec.) - \$17,670. Mr. Means gave Bd. comparison of what 'should' be & what contractors bid - and his prior estimates. In disc. re media/trickling filter, Mr. Elliott sd. that Village has sme. Need two, per Mr. Means. The Mayor asked if engineering fee included in contingency fee, legal & accounting services - and was told by Mr. Means "only for construction." He sd. no need to go over five per cent (5%) re contingency. The Mayor asked about Change Orders/Mr. Means sd. he did not anticipate sme. He mentioned possible negotiation re contract/unsure. Construction materials might cost less/he might offer a credit - can't negotiate. He queried Bd. about accepting low bid or reject and re-bid. Fewer bids than anticipated. Mr. Elliott spke. of 'unknown' re outcome; Mr. Means felt there wld. not be a savings - Hubbard anx./no work at present time; had wrkd.
