The Board fears that the residents are not aware of the costs involved to remedy the problem, and once presented in dollars to them, they would be amazed.

First let us consider the direction in which the housing development will take.

To the North we are in a fairly good condition with two conditions that I will take up later.

Easterly there is a possibility that there will be a Water District formed along Route 31, but I consider this not too urgent.

Southerly, we are expanding the Canandaigua Water District, and opening new roads. This will also be true out Stafford Rd. possibly to the Armington Rd. and maybe farther. While not under our present contract, this can be changed when the need arises.

To the West, there is talk of a District forming along old Route 31 and then southerly on Yellow Mills Rd.

With the above in mind I propose that we under take main increases as follows:

Continue the 12" main laid last year from Cuyler to Canandaigua.on

Jackson. Then North on Canandaigua with 8" to meet the 8" from Main St.

to the school. South from the intersection of Jackson and Canandaigua

with a 12" to the Fostered St intersection, at the same time relaying the

4" in the intersection with 8". Abandon the 4" now in use on Canandaigua

as it would cost more to take it up than it is worth.

Continue the 12" west on Jackson to Hyde Pk. Making arrangements for a right of way across the McLouth Property. This could be done over a period of a couple of years.

South from Jackson on Stafford with 12" to the intersection of Foster.

This 12" with the one on Canandaigua would give the Districts to the

South a good volume fo water.

The 12" running the length of Jackson St. would also help to feed Main St. by tying it into pipes at each intersection it crosses.

Thus we have our main feeder running through the center of the Village and feeding both ways.
