PERMISSIVE REFERENDUM: Motion was made by Trustee Husk, second by Trustee Nolan to adopt the following permissive referendum:

PERMISSIVE REFERENDUM/WTP:

NOTICE IS HEREBY GIVEN that the Board of Trustees of the Village of Palmyra, Wayne County, New York, adopted a resolution during a meeting on June 2, 2015, subject to Permissive Referendum as follows;

BE IT RESOLVED that a sum up to and not to exceed THIRTY THREE THOUSAND FIVE HUNDRED DOLLARS (\$33,500) shall be expended from the Capital Reserve Water (HR3) for the installation of the Corrosion Control Treatment Solution identified by the lead and copper study of March 2015.

Following publication, the foregoing resolution shall be posted in six (6) conspicuous places and in accordance with Section 9-902 of Village law, shall take effect in thirty (30) days.

<u>CELL TOWER LEASE:</u> After a brief history lesson on the cell tower, motion was made by Trustee Husk, second by Trustee Nolan to approve the Consent of Assignment of Telecommunication Facility Easement, the First Amendment of the Telecommunication Facility Easement Agreement and the Second Amendment to the Lease Agreement and to authorize Mayor to sign same. Vote, 4 ayes. CARRIED.

TRANSFER FROM CONTINGENCY: Motion was made by Trustee Nolan, second by Trustee Luke to transfer \$2500 from Contingency A1990.4 to Law A1420.4 to cover the Villages share of litigation costs for the Bamberger property appraisals. Vote, 4 ayes. CARRIED.

PCC LEASE: Tabled.

<u>AMENDED HIGHWAY AGREEMENT:</u> Effective June 1, the highway agreement will no longer include the \$15,000 for highway equipment repairs. Motion was made by Trustee Husk, second by Trustee Nolan to authorize the Mayor to sign the amended highway agreement. Vote, 4 ayes. CARRIED. All invoices for equipment maintenance and repairs will be done through the Village.

SEQR FOR TRAIL CONNECTOR AND TERMINAL WALL EXT.: Mayor Piccola submitted the Full Environmental Assessment Form for the Palmyra Canal Trail Connector and Terminal Wall Extension for Board review.

SEQR RESOLUTION – INTENT TO DECLARE LEAD AGENCY STATUS:

Motion was made by Trustee Nolan, second by Trustee Luke to adopt the following resolution declaring lead agency status for the Village:

"RESOLVED, that in accordance with the New York State Environmental Quality Review (SEQR) regulations, the Village Board of the Village of Palmyra hereby announces its intent to serve as Lead Agency to conduct an environmental review of the construction of the Palmyra Canal Trail Connector and Terminal Wall Extension Project. Approximately 3,200 linear feet of recreational trail will be installed along the former tow path and within the public ROW of NYS Route 21 in the Village of Palmyra, connecting the Village Marina to Breen's Supermarket. Additionally, an approximately 300 foot long terminal wall extension will be constructed along the canal from the boat launch (at the end of Park Drive) westerly to, and southwesterly along, Mill Brook.

FURTHER RESOLVED, the Village Board has determined that, while the proposed action is an Unlisted action as defined under SEQR, as portions of the project occur wholly or partially within, or substantially contiguous to the National Registered New York State Barge Canal Historic District, the proposed action is treated like a Type I action as defined under SEQR; and, be it

FURTHER RESOLVED, the Village Board acknowledges that Part 1 of the full Environmental Assessment Form has been prepared for this project by the Village Highway Department, and signed by the Village Mayor; and, be it

FURTHER RESOLVED, the Village Board will notify the Involved Agencies of its intention to act as Lead Agency for this project and will provide them with a copy of Part 1 of the full Environmental Assessment Form for review during the 30-day comment period.

Vote, 4 ayes. CARRIED.

<u>REAFFIRMATION OF THE COMPREHENSIVE PLAN:</u> Motion was made by Trustee Husk, second by Trustee Nolan to adopt the following resolution:

WHEREAS, the Palmyra Comprehensive Plan that was adopted by the Palmyra Village Board in December 2004 included the stated goals to: "provide a network of trails and sidewalks to provide for safe pedestrian travel within the community," "encourage tourism", and "continue to provide … recreational opportunities to Palmyra residents"; and

WHEREAS, the 2004 Comprehensive Plan specifically recommended that the Village and Town "support the efforts of Wayne County and the NYS Canal Corporation to construct segments of the Erie Canalway Trail especially the segment between Division Street and the Arcadia town boundary"; and

WHEREAS, subsequent to the completion of the Comprehensive Plan, the Village, along with local residents and stakeholders held a charrette which lead to the concept of the Palmyra Canalside Nature Park Project, of which two of the three phases are complete or near completion; and

WHEREAS, the proposed Canal Trail Connector and Terminal Wall Extension project is the only remaining component of the Palmyra Canalside Nature Park Project;

NOW THEREFORE BE IT RESOLVED, the Palmyra Village Board does hereby reaffirm the 2004 Comprehensive Plan's recommendation to "construct segments of the Erie Canalway Trail"; and

BE IT FURTHER RESOLVED that the Palmyra Village Board does hereby acknowledge that the proposed Canal Trail Connector and Terminal Wall Extension project will further the goals of the 2004 Comprehensive Plan to: "provide a network of trails and sidewalks to provide for safe pedestrian travel within the community,"

"encourage tourism", and "continue to provide ... recreational opportunities to Palmyra residents."

Vote, 4 ayes. CARRIED.

RESOLUTION TO SUBMIT CANALWAY GRANT AND PROVIDE A COST

<u>SHARE</u>: The anticipated cost of the Terminal Wall project is about \$206,000. Motion was made by Trustee Nolan, second by Trustee Luke to adopt the following resolution:

WHEREAS, the New York State Canal Corporation is offering funding under the Canalway Grant Program for projects which preserve and rehabilitate canal infrastructure, enhance recreational opportunities for water-based and land-side users, promote tourism, economic development, and revitalization of the canal corridor and the corresponding region; and

WHEREAS, the Village of Palmyra's Terminal Wall Extension project to provide increased frontage for boaters to tie their boats, beautify the canalside, and help prevent erosion and sedimentation into the canal qualifies under the Canalway Grant Program; and

WHEREAS, Palmyra's Terminal Wall Extension project is a high priority for the Village as part of the larger Palmyra Canalside Nature Park Project;

NOW THEREFORE, BE IT RESOLVED, that the Village of Palmyra Board of Trustees enthusiastically supports the submission of the Canalway Grant Program grant application by the Mayor;

BE IT FURTHER RESOLVED, that the Village of Palmyra hereby commits to providing 50 percent of the costs to design and construct the Terminal Wall Extension project.

Vote, 4 ayes. CARRIED.

RESOLUTION TO SUBMIT EPF GRANT AND PROVIDE A COST SHARE: The anticipated cost of the Trail Connector project is approximately \$200,000. This grant provides for a 75/25 split but Village may submit for a 70/30 split. Motion was made by Trustee Luke, second by Trustee Husk to adopt the following resolution:

WHEREAS, the Village of Palmyra is applying to the New York State Office of Parks, Recreation and Historic Preservation (OPRHP) for a grant under the Environmental Protection Fund for construction of the Palmyra Canal Trail Connector project located within the territorial jurisdiction of the Village of Palmyra;

NOW, THEREFORE, be it resolved by the Council that Christopher J. Piccola, as Mayor of the Village of Palmyra, is hereby authorized and directed to file an application for funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of Title 9 of the Environmental Protection Act of 1993, in an amount not to exceed \$500,000, and upon approval of said request to enter into and execute a project agreement with the State for such financial assistance to the Village of Palmyra for constructing the Palmyra Canal Trail Connector and, if appropriate, a conservation easement/preservation covenant to the deed of the assisted property.

BE IT FURTHER RESOLVED that the Village of Palmyra does hereby approve and endorse the application for a grant under the Environmental Protection Fund for a trail project known as the Palmyra Canal Trail Connector.

BE IT FURTHER RESOLVED, that the Village hereby commits to providing 30 percent of the costs to design and construct the Palmyra Canal Trail Connector project.

BE IT FURTHER RESOLVED that said property shall be forever maintained

by the Village of Palmyra as a municipal trail in this community consistent with the rules promulgated by OPRHP.

Vote, 4 ayes. CARRIED.

YEARLY TRANSFERS TO FIRE RESERVES: Motion was made by Trustee Perry, second by Trustee Husk to authorize the Clerk Treasurer to make the yearly budgeted transfers to both Fire Reserves. Vote, 4 ayes. CARRIED.

ADJOURNMENT: Motion was made and seconded to adjourn at 8:45 p.m. Vote, 4 ayes. CARRIED.
