HARBOR HOST PROGRAM: Tabled due to power outage.

BUDGET TRANSFER: Motion was made by Trustee Perry, second by Trustee Luke to transfer \$845 from A9015.8 Police and Fire Retirement to A9010.8 State and Local Retirement to cover the shortfall and pay the annual invoice from retirement. Vote, 4 ayes. CARRIED,

LEAD AGENCY: Motion was made by Trustee Perry, second by Trustee Luke to authorize the Mayor to sign the notice of lead agency intent, affirming that the Village has no objection to NYS DEC becoming Lead Agency for the Title V Modification at the High Acres Landfill and Recycling Center; stating the Village has no concerns at this time .
