## **RESOLUTION:**

RESOLUTION AUTHORIZING SALE OF LAND, THE GRANTING OF AN EASEMENT AND THE EXECUTION OF LEASE AND A CORRECTION DEED IN CONJUNCTION WITH THE CONSTRUCTION OF THE WESTERN REGIONAL WASTEWATER TREATMENT SYSTEM

WHEREAS, the Village of Palmyra has heretofore entered into an agreement with the Town of Marion, the Town of Macedon, the Town of Walworth, the Town of Palmyra and the Wayne County Water and Sewer Authority for the construction of a wastewater treatment facility to serve the participating municipalities; and

WHEREAS, in order to accommodate the construction and operation of the Regional Wastewater Treatment System it will be necessary for the Village of Palmyra to transfer title of certain real property to the Wayne County Water and Sewer Authority and to execute an access easement, driveway maintenance agreement along with a Correction Deed to be executed between the Village of Palmyra and Breen's Realty & Leasing Corp. for property heretofore transferred from the Village to Breens as recorded in Liber 788 of Deeds at page 670; and

WHEREAS, the Village of Palmyra desires to execute the Correction Deed to Breen's Realty & Leasing Corp and to transfer title of Village property located at No. 613 and 617 East Main Street to The Wayne County Water and Sewer Authority and to execute and deliver to the Wayne County Water and Sewer Authority the Deed and any and all other documents necessary to effectuate said transfer including those documents necessary to enter into the driveway maintenance agreement and easement.

NOW THEREFORE BE IT RESOLVED that the Village Board of the Village of Palmyra in regular session duly convened on February 22, 2021, does hereby authorize and direct the Mayor of said Village of Palmyra to execute and deliver to The Wayne County Water and Sewer Authority the Deed, Driveway Maintenance Agreement, and Easement and all other documents necessary to accomplish same for the property located at No. 613 East Main Street and being known as Tax I.D. No. 65111-09-056642 and a portion of the property located at No. 617 East Main Street and being known as Tax I.D. No. 65111-09-022632; and

AND BE IT FURTHER RESOLVED that the Village Board hereby authorizes the Mayor to execute and deliver to Breen's Realty & Leasing Corp. the Correction Deed, and all other documents necessary to accomplish same for the property located at No. 611 East Main Street and being known as Tax I.D. 64111-12-992659; and

AND BE IT FURTHER RESOLVED that the Village Board hereby authorizes the Mayor to execute a lease back agreement between the Village and the Wayne County Water and Sewer Authority for the real property being transferred to the Authority with said wastewater treatment plant being operated by the Wayne County Water and Sewer Authority under the existing Operating Agreement until such time as the new wastewater treatment plant comes on line.

Motion was made by Trustee Perry, seconded by Trustee Warters. Votes, 4 ayes. CARRIED
