TRUSTEE REPORTS

Trustee Bradstreet reported that he met with the Code Enforcement office, the property manager and the future buyer of Salzburg Village about how the apartments will be inspected. CEO Wooden will attend the first meeting in May to report on a proposed rental housing code.

Trustee Husk was absent but Trustee Piccola reported on his behalf that Engine 25 is out of service, it needs a fuel sling. NEW/OLD BUSINESS:

<u>KIOSK UPDATES:</u> The kiosk at the corner of Market and Canal Street is in desperate need of a facelift. Mayor Daly suggested using the unspent funds from the kiosk grant to pay for the face lift. The maps need updating and the images need replacing. The estimate for upgrading the two kiosks should not exceed \$1200. Motion was made by Trustee Piccola, second by Trustee Nolan to update the kiosks not to exceed \$1200 to be expended from the pedestrian grant if possible. Vote, 3 ayes. CARRIED.

COPIER OFFER: Motion was made by Trustee Piccola, second by Trustee Nolan to accept the offer of \$1000 for purchase of the BizHub350 (the old copier) from the Hemlock Fire Department. Vote, 3 ayes. According to Michael Brecker, service manager, with Konica Minolta the fair market value of our 2006 BizHub 350 would be anywhere from \$800 to \$1100.00.
