<u>TIMBER HARVEST CONTRACT AND BID PROPOSAL:</u> Attorney Williams submitted a final contract for the timber harvest which may also be used for the bid specifications. Mayor Piccola reviewed the advertisement for bids. Motion was made by Trustee Perry, second by Trustee Nolan to approve said contract and instruct the Clerk to advertise for bids as described. <u>CONTINGENCY TRANSFER:</u> Two contractors have submitted estimates for replacement of the sidewalks that were damaged during the fire in May; one was for \$9450 and the low bid of \$7225 was submitted by AEY. Motion was made by Trustee

Nolan, second by Trustee Luke to award the job to the low bidder AEY. Vote, 4 ayes. CARRIED. Motion was made by Trustee Nolan, second by Trustee Husk to approve the transfer of \$2000 from A1990.4 Contingency to A5410.4 Sidewalks Misc. Contractual to cover the resultant budget shortfall in that line item. Vote, 4 ayes. CARRIED.

PARK DRIVE PROJECT/AIR MONITORING: Estimates were solicited for removal of the Park Drive house, Empire Contracting submitted an estimate of \$25,000 and Frederico Construction submitted an estimate of \$18,160. Motion was made by Trustee Husk, second by Trustee Perry to engage Frederico Construction and Demolition for removal of the Park Drive house. Vote, 4 ayes. CARRIED. The estimate for the air monitoring came in from Lozier, the company that did the original asbestos survey. It is for \$1026. Motion was made by Trustee Perry, second by Trustee Husk, to hire Lozier for the Asbestos Air monitoring during the Park Dr. house demolition. Vote, 4 ayes. CARRIED.

EXECUTIVE SESSION: Motion was made by Trustee Nolan, second by Trustee Luke to enter executive session for discussion of police personnel at 7:35 p.m. Vote, 4 ayes. CARRIED.

PUBLIC SESSION: Motion by Trustee Nolan, second by Trustee Luke, to move back into public session with no action having taken place at 8:05 p.m. Vote, 4 ayes. CARRIED.

POLICE OFFICER: Motion was made by Trustee Husk, second by Trustee Nolan to offer a full-time police officer position to Officer A at a provisional rate of \$18.23 per hour. Vote, 4 ayes. CARRIED.

ADJOURNMENT: Motion by Trustee Perry, second by Trustee Nolan to adjourn at 8:06 p.m. Vote, 4 ayes. CARRIED.
