Mayor Piccola reported that the new police car is supposed to be in this week. In order to sell the 2005 car, he would like to have it put a For Sale sign on it and display it in Fire Department parking lot as well as advertising for sealed bids. EXECUTIVE SESSION: Motion was made by Trustee Nolan second by Trustee Husk to enter executive session for discussion of the refinancing of a microenterprise loan including personal financial information. Vote, 3 ayes. CARRIED.

MICRO ENTERPRISE LOAN: Motion was made by Trustee Nolan, second by Trustee Husk to authorize the Mayor to sign the refinancing paperwork for D. Mead, Logo Factory, Micro Enterprise Loan amount of \$9310.00 for six years, at the original interest rate which works out to be \$144.62 per month. Vote, 3 ayes. CARRIED.
